1. The race organisers (including HBSC and the Hornet Association) shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner/competitor, his/her helm or crew as a result of their taking part in the race(s). Moreover, every owner/competitor warrants the suitability of his/her boat for the race(s).

2. The provision of safety equipment and boats by HBSC neither guarantees that assistance can be rendered to any competitor in need, nor an acceptance of any responsibility for rescue of competitors. Further, in the event that assistance is rendered to any competitor, neither the Club/Association nor the crew of such safety craft accepts liability for any loss, damage or injury to the competitor and/or the boat and its equipment.

3. RRS Fundamental Rule 4: The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.

4. I agree to be bound by the Racing Rules of Sailing and by all other rules that govern this event.

5. I hold and will produce a current measurement certificate for the above boat and membership of the Hornet Association.

6. I declare that I hold a valid certificate of insurance that also covers me whilst racing (including Third Party Liability cover of at least £2,000,000) and which will be valid for the duration of the event.

7. I understand that if the boat is in the charge of any person other than the undersigned, it is the responsibility of the undersigned to bring to the attention of the person in charge of the boat the provisions of this entry form. In addition I will also make the crew aware of these undertakings.
